## Program:

Impact of Serious or Chronic Illness on Career Continuity Clients with serious long-term or chronic illnesses often face daunting challenges in the workplace. These illnesses, whether physical or mental, may affect our clients' ability to find and maintain employment, and to achieve career continuity.

Lauren Gordon, LCSW, and Heidi Ravis, LMHC, will focus on specific scenarios, including cancer, mental illness, and chronic conditions which require ongoing vigilance and monitoring (e.g., autoimmune disorders). We will also address the challenges faced by caregivers of those coping with these illnesses.

Our discussion will also cover strategies and resources for assisting these populations, including the Americans with Disabilities Act (ADA) and the Family and Medical Leave Act (FMLA). We will also address current concerns and considerations we must be aware of as career professionals assisting them.

**Heidi Ravis,** EdM, is a Licensed Mental Health Counselor, National Certified Counselor and Distance Credentialed Counselor. In her 25+ years as a career counselor, she has worked with diverse client populations in a range of settings including higher education, community mental health, private practice and consulting. She currently consults for REA – Partners in Transition, Hand & Associates, and The Muse, while maintaining a private career counseling practice in Westchester County.
